Local Dues Update:

Over the past two years, our local membership has grown steadily, and we are grateful for the continued engagement and support of our member firms. As we look ahead, our priority remains clear: to deliver meaningful value to our members while continuing to attract and retain high-quality firms within our ACEC San Diego Chapter.

To ensure we are meeting those expectations, the Board of Directors recently conducted a thoughtful review of our local dues structure and member benefits. Our local dues have remained unchanged for the past 10 years. During that same period, inflation has risen by more than 35%, significantly increasing the cost of hosting meetings, providing meals, and delivering quality programming.

We are committed to continuing to include General Member Meetings (GMMs) — including lunch — as part of your annual dues, rather than moving to a pay-per-event model. We also see opportunities to enhance the value of membership by offering additional GMMs, mixers, and social events that foster connection, professional growth, and industry collaboration. In the coming weeks, we will circulate a brief poll to gather your input and ensure our programming aligns with what matters most to you.

After careful consideration, the Board has approved a 13% increase in local dues, which remains well below the cumulative inflation experienced over the past decade. This measured increase will allow us to sustain the quality of our programs, continue providing GMM lunches as part of membership, and thoughtfully expand our offerings to better serve you.

We do not take any dues adjustment lightly, and we sincerely appreciate your understanding and continued support. Your participation and engagement are what make our chapter strong, and we look forward to another successful year together.
